ANY CAT/DOG WHO IS FOUND TO BE SUFFERING FROM AN INCURABLE DISEASE OR WHO DEMONSTRATES SNAPPING, BITING, OR AGGRESSION TOWARDS ADULTS OR CHILDREN COULD BE EUTHANIZED.
